Happy New Year! I am looking forward to this tax season. There are a lot of new changes to update everyone on that I believe will be a big benefit.

Please let me know:

- If you had overtime pay in 2025. Please bring in your last paystub from 2025.
- If you purchased a **brand-new** vehicle in 2025 and it was assembled in North America you might be able to deduct the interest. Please bring along December's interest statement.
- If you are a PA resident over the age of 65 and make less than \$46,520, as you will probably qualify for a property tax or rent rebate through PA.

If you would like to find out about more changes throughout the year, please like my Facebook page. I post changes as information becomes available.

Scheduling: To schedule an in-person appointment, I would recommend calling in before the middle of February to ensure availability. My wife does a great job with all the scheduling and phone calls. If she does not answer, she is most likely on a call with another client. Please leave her a message and she will get back to you as soon as she can; however, she may call back from a different number. You are welcome to drop off your paperwork ahead of time to reduce the duration of your scheduled appointment, if you do this please let the staff know your appointment date and time.

Office Hours: Monday– Friday 10am– 8pm (Friday 4-8PM is only in Elizabethtown Office and by appointment only)

Drop-Offs: Tax return information may be dropped off instead of scheduling an appointment, but we understand that will not work for everyone. No appointment is needed for a drop-off. Last year the majority of the drop offs were completed in less than a week. If you are dropping off paperwork you can do that at either one of our two locations. If no one is in the office you can drop your paperwork in the large mail slot in the entrance door at either office location, 115 E. Main St. Mount Joy or 149 E. Willow St. Elizabethtown. If you are dropping off, please fill out the information form that is included in this letter and include it with your paperwork.

We also have an option to submit your tax documents online instead of dropping them off. My website JonsTaxService.com has a secure Client Portal. If you would like to use this feature, just go to my website to sign up and you will be approved within 24 hours. If you have used it in the past your login will work again this year. If you use this feature and can upload all your documents at one time as a single file, that is preferable to submitting multiple uploads. Feel free to reach out to us if you need help or have any questions.

Client Organizer: If any of you would like a personalized client organizer to help you collect the data required for your return based off of last year's information, please email me at Jon@JonsTaxService.com and I will email that to you or send it to you in the portal if you signed up. I also have some other organizers for rentals and businesses on our website under that tax forms tab.

Partnerships and Corporations if you can get me your information in January or early February that would be great to ensure they are completed by the deadline.

Refund Advances Available: If you need your refund in a hurry, I am also able to offer advances on your refund through EPS Financial and have tax prep fees subtracted from your refund. Deadline for refund advance is March 15th.

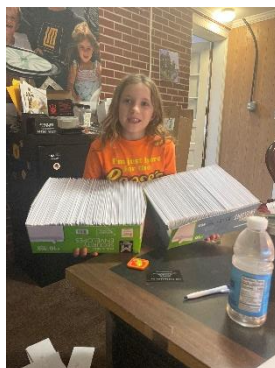
All e-filed taxes returns will again have FREE Audit Protection and ID theft restoration.

Forms of Payment Accepted: We accept cash, check, eCheck, or credit card payments. While I can accept credit cards for payment, I want to make everyone aware that the **credit card processor charges the client an additional 3% processing fee**. I prefer checks or cash because it saves you the credit card fees. I am also able to pull the tax preparation charges out of your bank account without any additional fees to you.
